GRADING POLICY:

Your grade will be determined as follows: There will be

- 10 homework sets with 8 problems each, worth 1 point each.
- 4 in-class exams with 6 problems each, worth 3 points each.
- a final comprehensive exam with 10 problems, worth 3 points each.

For a **rough estimate** of your letter grade you can then use your overall percentage over this total of 182 points and the scale below

100-90 A, 89-80 B, 79-70 C, 69-50 D, 49- F.

GUIDELINES AND RULES:

- 1. This is a very intense class in terms of pace. Do not loosen up at any point during the semester. You will find it extremely **hard to catch up!**
- 2. Every problem counts! As you may see from the given scale, it may make a huge difference at the end whether your average is 80.2% or 79.8 %. So, make sure that you work systematically and hand in your homework on time. The percent allocated to them may seem small but it may make the difference.
- 3. Solving your homework problems only will not be enough. These assigned problems will hopefully be enough for me to fairly evaluate your performance and assign your grades but will not be enough for you to do well. You need to try and do as many of the book problems as possible to master the material and to be well prepared for the exams.
- 4. Feel free to use your calculators to verify your answers in the homeworks. Make sure, however, that you **show full work** and know how to do the problems without using your calculators, as **they will not be allowed** during exams!
- 5. **If you are an athlete**, make sure to hand in your homework **before** you go on a trip, if you will be gone on the due date. Late homeworks will **not be accepted** under any circumstances.

6. Do not call me during or after an exam to ask for a make up. I will say "NO!". In particular, I will disregard any messages left on my machine after I leave the office for the classroom to give an exam. If you have an emergency, make sure to contact me before the exam to arrange for alternatives.

EXAM POLICIES:

- Each of the four 1-hour exams will consist of 6 problems some of which may have multiple parts.
- Calculators and notes will **not** be allowed.
- Make-ups will not be given unless there is a **verifiable emergency** and notice is **given** in advance.
- Evaluation of your exam is your instructor's responsibility. You are welcome to ask questions on points that you don't understand and point out possible mistakes but you should **not** question the **grading policies**. They are set in advance according to my best judgement and they are applied uniformly to everyone.

HOMEWORK POLICIES:

You will be required to hand in approximately 1 homework set per week. They will consist of 8 problems. These problem sets will be handed-out at the beginning of some lecture period. No late homeworks will be accepted.

- Feel free to ask many questions during the lectures and to use my office hours for discussions and questions as much as you want. Do **not** think that you are disturbing me if you stop by often. The office hours are for you to get extra help if you need it.
- Attend the Supplemental Instruction sessions and ask your instructor for help concerning homework problems if help is needed. Asking and getting answers is the only way to clarify your understanding of the material.
- If needed, arrange to take advantage of the tutoring services located at the basement of the library. People in charge there will be able to provide additional help.
