#### **GRADING POLICY:**

Your grade will be determined as follows: There will be

• 14 in-class tests with 5 problems each, worth 5 points each (total 350).

• a final comprehensive exam with 10 problems, worth 5 points each (total 50).

For a **rough estimate** of your letter grade you can then use your grade over this total of 400 points and the scale below

100-90 A, 89-80 B, 79-70 C, 69-50 D, 49- F.

# **GUIDELINES AND RULES:**

- 1. This is a very intense class in terms of pace. Do not loosen up at any point during the semester. You will find it extremely hard to catch up!
- 2. **Every problem counts!** As you may see from the given scale, it may make a huge difference at the end whether your average is 80.2% or 79.8 %. So, make sure that you work systematically and do homework problems from every section that is covered in class every day!
- 3. Feel free to use your calculators to verify your answers in your homework. Make sure, however, that you know how to do the problems without using your calculators, as **calculators will not be allowed** during exams!
- 4. **If you are an athlete**, make sure to **contact me before** going on a sports trip to arrange for make-ups!
- 5. Do not call me during or after an exam to ask for a make up. I will say "NO!". In particular, I will disregard any messages left on my machine after I leave the office for the classroom to give an exam. If you have an emergency, make sure to contact me **before** the exam to arrange for alternatives.

## **EXAM POLICIES:**

• Each of the fourteen 50-minute tests will consist of 5 problems some of which may have multiple parts.

- Calculators and notes will **not** be allowed.
- Make-ups will not be given unless there is a **verifiable emergency** and notice is **given in advance**.
- Evaluation of your exam is your instructor's responsibility. You are welcome to ask questions on points that you do not understand and point out possible mistakes but you should **not question the grading policies.** They are set in advance according to my best judgement and they are applied uniformly to everyone.

#### **HOMEWORK POLICIES:**

You will not be required to hand in any homework. I will, however, be giving you a list of problems for you to practice at home from every section that will be covered in class. A list of approximately 5 problems from each section will be given. You **need** to work on these problems and make sure that you know how to do them before every test. It is **your responsibility** to ask either a tutor or myself for help if you cannot solve any of these problems.

- Feel free to ask many questions during the lectures and to use my office hours for discussions and questions as much as you want. Do **not** think that you are disturbing me if you stop by often. The office hours are for you to get extra help if you need it.
- Attend the Supplemental Instruction sessions and ask your instructor for help concerning homework problems if help is needed. Asking and getting answers is the only way to clarify your understanding of the material.
- If needed, arrange to take advantage of the tutoring services located at the basement of the library. People in charge there will be able to provide additional help.
